Bookings:

To make a booking, please fill in and sign the booking form and send it back to us together with the deposit.

If we still have availability for your dates, we will confirm your booking in writing and send you a receipt.

If the booking is not possible, we will inform you in writing or by telephone and return your deposit in full.

Pitches are rented to the person named on the booking form and cannot be sub-let under any circumstances.

Payment:

A deposit of 30% of the total holiday price is required to secure your booking.

The booking fee is not deductible.

The balance of the holiday, that is the remaining 70%, must be paid in full one month before the start date of your holiday. We will not send out a reminder or follow-up letter.

If payment is not received by the due date, your booking will be cancelled and your deposit retained.

Cancellation:

Any cancellations of holidays must be made in writing. If you cancel more than 60 days before your holiday start date, the deposit of 30% will be refunded. If you cancel between 60 and 30 days before your holiday start date, the deposit is no longer refundable. If you cancel less than 30 days before your holiday start date, we will keep the total amount of payments received and the total amount of the holiday is due.

Late arrivals or early departures:

No reduction will be made in the case of late arrivals or early departures. Under no circumstances will we reimburse any costs for holidays where you leave before the due date. Your pitch booking is held for you up to 24 hours after your due arrival date; if the client does not show up within this time, the pitch will be let out by the campsite and the total amount paid will be forfeited.

Insurance:

Each camper should be insured for Civil Liability. Please note that you can take out an insurance policy covering eventual cancellation or interruption of your holiday with your insurance company.

Security Bond:

A cheque for the amount of €250 or a credit card number plus the expiry date is required on arrival. This will be refunded on departure less any charges due for breakages or missing items. Please leave your accommodation spotless! If not, we will keep the security bond of €50 against final cleaning.
